

## WE PLAY CAMP LIABILITY Waiver AND RELEASE

As part of the consideration for the agreement of Lizzy Stemke, LLC to allow my child to participate in the We Play Camp and all activities associated with or conducted during the course of the camp, and the agreement of the Canterbury School to allow its campus to be used for the We Play Camp, (activities all collectively hereby referred to as the "We Play Camp"), I hereby freely make the following representations and enter into this agreement:

1. This agreement will apply to the Canterbury School and to Lizzy Stemke, LLC, and the directors, officers, coaches, employees, contractors, agents and all other persons, affiliates and subsidiaries connected with them, as well as their heirs and executors and successors and assigns (collectively referred to as the "We Play Camp Organizers").
2. This agreement is made on behalf of the individuals who execute the agreement below. In the cases where a parent or guardian executes this Agreement, such parent or guardian hereby acknowledges and agrees that, for purposes of this agreement, "I" shall mean such parent or guardian, any other present or future parent or guardian of the child listed herein, the child, and the personal representatives, heirs, successors, and assigns, therefore, with the result that all such parties are bound by the terms of this agreement.
3. I understand that during my child's participation in the We Sports Camp, my child may be exposed to a variety of hazards and risks, foreseen and unforeseen, which are inherent in athletics and contact sports, and cannot be eliminated. These hazards and risks include, but are not limited to, the dangers of serious personal injury, property damage, and death. I know that injuries and damages can occur by natural causes or activities of other persons, flora, fauna, viruses, bacteria, parasites, and insects, or other participants in the We Play Camp.
4. I fully realize, accept, acknowledge and understand the hazards of having my child participate in the We Play Camp and voluntarily assume all of the risks associated with such participation, whether such risks are known or unknown or listed herein, and whether such risks arise out of the negligence of the We Play Camp Organizers.
5. I understand and agree that it is my sole responsibility to be familiar with and ensure that my child is capable of handling the physical and mental demands associated with the We Play Camp and I accept that responsibility.
6. I, for myself, my child, and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS all WE Play Camp Organizers, and all coaches, officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, owners and lessors of premises used to

conduct the camp (“RELEASEES”), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

7. I understand and agree that the We Play Camp Organizers may alter the We Play Camp at their discretion without prior notice including but not limited to alteration of the planned activities or cancellation of activities due to weather, pandemic, or other circumstances.
8. I understand and agree that the We Play Camp Organizers can refuse to retain my child as a participant in the We Play Camp at its sole discretion.
9. I agree that the provisions of this agreement shall not be construed in favor of or against the party who drafted the agreement. In the event that any clause or provision of this agreement shall be held invalid, I agree that the remaining provisions shall remain in full force and effect.
10. By signing the Parent/Guardian line below, I represent and warrant that I am the parent or legal guardian of the child listed below.
